Mr. MacCleery called the meeting to order at 6:00pm.

#### Replacement of the Forestry 1 Truck-

The replacement of the forestry truck was approved at the 2024 town meeting in the amount of \$190,000 to come out of the Capital Reserve Fund.

Chief Quimby came before the Board with a proposal to purchase a forestry/mini pumper truck that meets or exceeds the town's requirements as a forestry truck/multi response vehicle. The Truck is located in Pennsylvania at Command Fire Apparatus who offered \$6,000 for a trade in value for the current forestry vehicle.

The Board discussed if the Town could get more than \$6,000 if it were sent out to bid or auction. The consensus of the Board was to keep the truck and not trade it in.

Mr. Williams made a motion and Mr. Bouchard seconded to approve the purchase of a 2009 4-Guys Ford F-550 forestry/mini pumper, current mileage 9,400 from Command Fire Apparatus for \$173,000 from the Fire Rescue Apparatus and Equipment Capital Reserve Fund, which includes a 5-year powertrain warranty, and \$3,000 to ship the truck to New Hampshire. **Motion passes.** 



Chief Quimby stated he would request to utilize the remainder of the funds to purchase radios, compartmentation, outfit, and to letter the truck.
