DECEMBER 15, 2023 TRUSTEE MEETING APPROVED MEETING MINUTES

The Chichester Trustees of the Trust Funds met at 9:00 AM at Chichester Town Hall on December 15, 2023. The Meeting was called to order at 9:05 AM. Trustees present were:

- 1. Reviewed and Approved November 17, 2023 Trustee Meeting Minutes.
- 2. November TD Bank statement Check # 248 was unprocessed as of the date the November TD Bank Statement was printed. The current balance in the checking account was verified electronically. Check # 248 has been processed. The \$236.99 closing balance of the Bear Hill ETF was transferred to the General Fund. The final, reconciled balance is the \$1.00 Ending Maintenance Balance.
- 3. Withdrawal from Municipal Transportation Fund Check # 252 in the amount of \$85,000 was written to Town of Chichester from the Municipal Transportation Fund. This fund includes the local portion of vehicle registration fees and is administered by the Board of Selectmen.
- 4. Withdrawal from Town Owned Parking Lot CRF The Town of Chichester requested a \$31,500 withdrawal from the Town Owned Parking Lot CRF for paving the lower parking lot at Town Hall. The request is supported by an invoice from R Cooper Paving. The Selectmen approved the \$31,500 withdrawal at their October 17, 2023 Selectmen's meeting. Motion to approve requested \$31,500 withdrawal from the Town Owned Parking Lot CRF. APPROVED UNANIMOUSLY.
- 5. Withdrawal from Fire Radio & Equipment Repair/replacement ETF The town of Chichester requested a \$22,735.95 withdrawal from the Fire Radio & Equipment Repair/Replacement ETF to replace 15 obsolete radios. The request is supported by a \$22,735.95 invoice from Beltronics for 15 Kenwood portable radios and related equipment and supplies. The selectmen approved a \$23,123.98 withdrawal at its September 6, 2022 Selectmen's meeting. MOTION to approve requested \$22,735.95 withdrawal from the Fire Radio & Equipment Repair/Replacement ETF. APPROVED UNANIMOUSLY.
