Mr. Brehm called the meeting to order at 6:31pm

Mr. Houle made a motion and Mr. Jameson seconded to approve the minutes of 12/05/2019 with one minor change. **Motion Passes.** 

Proposed Changes to the Building Code-

Mr. Hodge reviewed the proposed changes to the building code.

Mr. Healy made a motion and Mr. Bouchard seconded to move the changes to the ballot for vote. **Motion** passes.

**Public Hearing-Proposed Zoning Updates** 

Mr. Hodge discussed the changes he put forward to clarify the accessory dwelling unit ordinance. The Board made minor changes including removing the word manufactured in 3.21 D (2) and renumbering current items.

The Board discussed the addition of the word 'portable' to sawmills in the residential district in section 2.04 as it was an error and mistakenly left out in a prior year. Mr. Brehm explained it was just housekeeping to correct the missing word.

The Board also discussed the addition of "interconnectivity" between abutting sites being permitted in general.

The Board reviewed Conditional Use Permits (CUP) for Home Occupations and accessory dwelling units. Mr. Monahan is going to have some discussion with the Town attorney regarding these and depending the outcome and amount of changes made the Board may have to have a second public hearing.

Mr. Brehm made a motion and Mr. Houle seconded it to move to the ballot for a vote. All in favor. **Motion passes.** 

Master Plan Update-

The Board reviewed the Master Plan chapters completed by CNHRPC. Mr. Brehm is going to organize a meeting with a few Planning Board members to review the chapters more thoroughly with Mr. Tardiff.

The Board will then review them again at the 1/23/2020 meeting and the public hearing will be set for February 6, 2020 to adopt the completed chapters.
