## **Budget Schedule-**

## **Zoning Violations-**

Mrs. Pinard stated that the violations for Coleman Concrete are being reviewed by Town Council and they will be contacting the attorney that represents Coleman Concrete.

## **Fire Department-**

Chief Quimby requested support for a grant to replace and upgrade the Fire Department radio system with the Capital Area Fire Mutual Aid System.

## **Tax Rate Setting-**

Mrs. Pinard stated that the tax rate set by the Department of Revenue Administration is \$16.42 per thousand, which is down 7.96. The DRA does not recommend using any fund balance as it is below the recommended amount.

## Discussion on West Road-

Mrs. Parent came before the Board to discuss the progress on West Road. She had questions regarding the Town Engineers recommendations and if they were followed. She stated her concern for the rip rap being covered in dirt and worried that the road would be in the same position in the spring. She stated that when Busby graded it properly and rolled it, it was in very good shape and asked why they couldn't do that again.

The Board stated that they used the Town Engineers recommendations for a temporary fix to make it through the winter and the Town will need to decide on what to spend in the future.

Mr. MacCleery stated that he believes that different material needs to be used on the road.

Mr. Bouchard agreed and said that reclaim material would be better suited.

Mr. Millette stated that there are lots of restrictions on the road and the water has to go somewhere. Tt comes down to resources.

The project is ongoing and should be completed by the end of the month.
