Mrs. Pinard stated that the employees are formally requesting hazard pay as an expense to paid out of the CARES ACT/GOFERR Corona Virus Relief Fund. This means it has no impact on the Town budget of taxpayers.

After some discussion, the Board agreed to pay the six employees requesting hazard pay the same amount that the first responders received for their stipend depending on Full or Part time status.
