## Chichester Board of Selectmen

Minutes of Meeting Tuesday October 27, 2020

Call to Order: Mr. Bouchard called the meeting to order at 6:00pm.

## Loader-

The Board received pictures of the loader for sale on Bear Hill Road. This loader is five years older than the current Highway loader and has over 10,000 hours on it.

The Current loader has been reviewed by Scott Decota who provided a quote in the amount of \$60,979.00 to make the necessary repairs.

The Board also discussed the option of a rental in the amount of \$18,750.00 for five months.

Mr. Millette stated that he does not want to waste money on repairs for a machine that is not worth it. It has a \$12,000 trade in value.

Mr. Bouchard discussed getting a quote to make the bare minimum requirements to make it safe and reliable.

Mr. Weir stated that all options need to be look at. The used machine is only a 4-5-year solution and he feels that it is the lowest risk and most reward.

Equipment East is currently holding the rental for the Town and needs an answer by the end of the week.

Mr. Bouchard made a motion to have the loader sent out to be repaired not to exceed \$20,000 with a quote for work received first. Mr. Weir seconded. Roll call vote. Weir, aye. Bouchard, aye. Millette, aye. Motion passes.

Mr. Millette made a motion and Mr. Bouchard seconded to approve the rental from Equipment East for a 5-month rental in the amount of \$18,500.00 for use this winter. Roll call vote. Weir, nay. Bouchard, nay. Millette, aye. **Motion fails.** 

Mr. Weir stated that he would get quotes for the loader to be repaired. He also stated that he would provide Mr. Sykes with a list of contractors for plowing.

Mr. Millette stated that they must be licensed and insured.

Mr. Bouchard stated that he still would like to move forward with equipment evaluation.
