Corrections to Main Street brochure - Lucille informed members that Tim (Granite Images) had made several changes to the brochure and asked an insert sheet be printed and added to the current supply of brochures. Kate volunteered to type and copy. After some discussion, Ed offered to take the changes to Granite Images to have them update/correct their file, obtain a proof for Lucille's review and order 250 copies. Everyone agreed.

Programs - Andrew Cushing of the NH Preservation Alliance has a program of interest "Reinvisioning Uses for Buildings" through NH Humanities. Lucille will follow-up for a program date.

Moose Plate Grant for Town Hall signage - Lucille advised the town's proof of insurance is required in order to obtain funds. Ed committed to follow-up with Jodi to send a copy to Amy Dickson.

Spring Clean-up of Main Street - Laurie Littlefield-Baas has offered to coordinate the event to cover Main Street from Rt 4 to Rt 28. It was suggested to hold it close to Earth Day (Apr 22); and to get as many organizations involved as possible - school, scouts, Grange, etc.

Richard inquired about the true status of "Historic Main Street." Lucille explained that Main Street has not been officially designated as an historic district because of limitations to landowners but there are a number of Main Street properties linked to town and state history.
